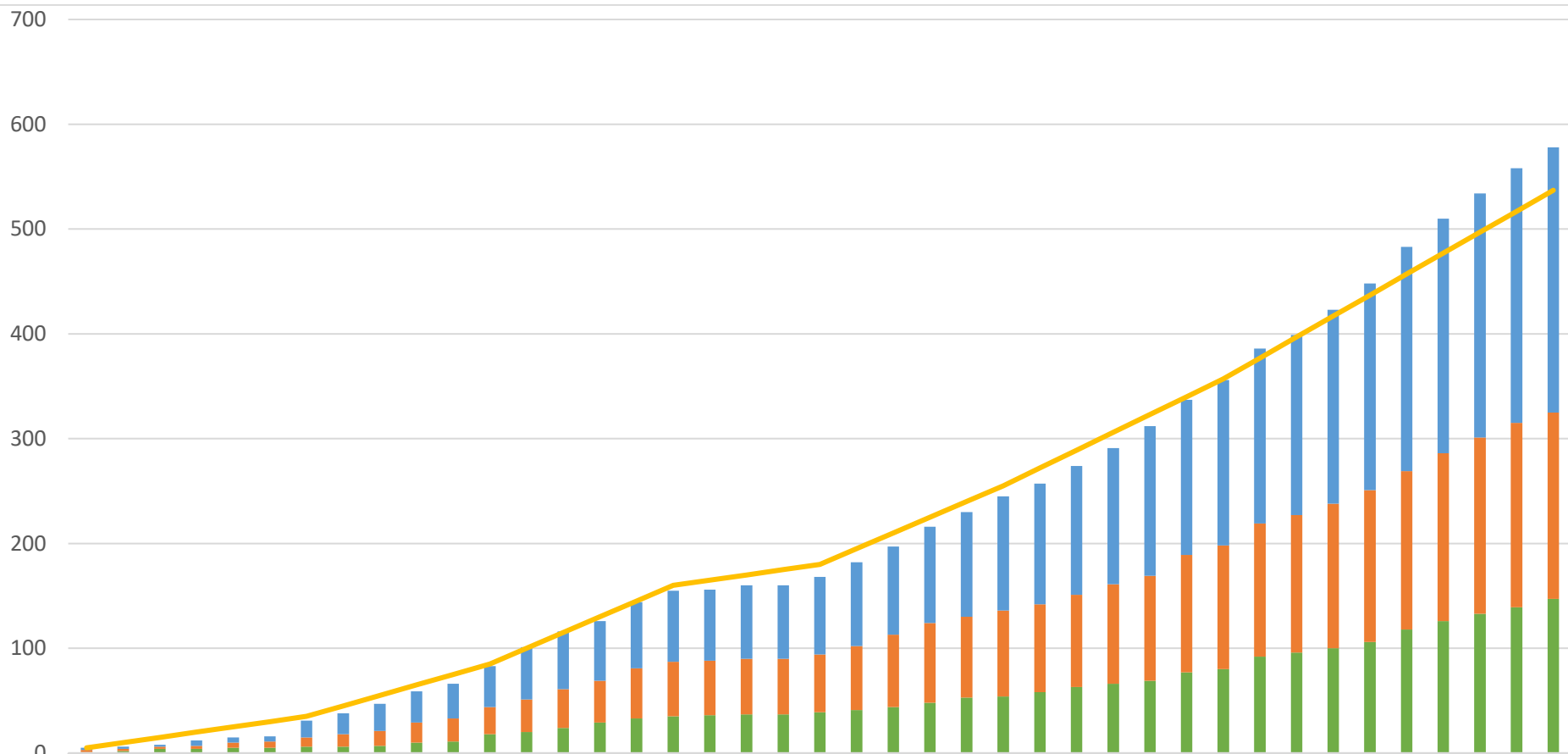
REMINDER
